Targeted support	Ensuring enough time for school maths-lead to support teaching for mastery approach across school.	New maths leader to share role with Headteacher. Follow Maths Hub and EEF guidance re effective intervention strategies.
Wider strategies	Engaging the families facing most challenges.	Working closely with families to support learning both in school and remotely. Access DfE laptop and router access programmes.

Review: Last Year's Aims and Outcomes

Aim	Outcome
Progress in Reading and Writing	Disadvantaged pupils made good progress. No national tests took place due to Covid-19.
Progress in Mathematics	Teaching for Mastery approach was further embedded. Two Maths Hub workgroups were engaged with.
Phonics	All KS1 staff have attended Read Write Inc. training.
Other	Attendance has improved, particularly of SEND pupils – now consistently above national average.
